

**PROVISIONAL RESOLUTION PROPOSAL FOR THE “CARLOS V EUROPEAN AWARD”- EUROPEAN  
DISABILITY FORUM EUROPEAN RESEARCH AND MOBILITY GRANTS FOR EUROPEAN STUDIES**

Having examined the applications submitted in relation to the call for the “Carlos V European Award”- European Disability Forum European Research and Mobility Grants for European Studies, the following are established as

**FACTUAL BACKGROUND:**

**FIRST.** – On 14 May 2018, the Official Journal of Extremadura (DOE), No. 92, published Decree No. 54/2018, of 8 May, by which the regulatory bases of the “Carlos V European Award” European Research and Mobility Grants for European Studies” of the European and Ibero-American Academy of Yuste Foundation were approved.

**SECOND.** – On Tuesday, 05 August 2025, the DOE No. 150 published the announcement of 30 July 2025, making public the call for applications for the “Carlos V European Award”-European Disability Forum European Research and Mobility Grants for European Studies of the European and Ibero-American Academy of Yuste Foundation, also disseminated through its website ([www.fundacionyuste.org](http://www.fundacionyuste.org)).

**THIRD.** – Within the deadline established in the sixth base of the call, a total of 17 applications were submitted, of which 15 were deemed eligible for evaluation by the jury. In addition, one application arrived after the deadline.

**FOURTH.** – On 04 November 2025, the jury appointed for this purpose, in accordance with the fifth and seventh bases of the call, having completed the evaluation phase of the submitted applications, issued the evaluation report, including the list of applicants arranged according to the score obtained.

The following are the **LEGAL GROUNDS** applicable to the foregoing factual background:

**FIRST.** – This proposal for a resolution is issued under the authority of points five and six of the seventh base of the announcement of 8 May 2018, which regulates the bases of the call and establishes that the competence to issue this provisional resolution belongs to the instructing body, in light of the file and the evaluation by the jury.

In view of the above, and considering the provisions of the regulatory bases and other applicable regulations, the following provisional resolution proposal is made. The instructing body, director of the European and Ibero-American Academy of Yuste Foundation,

## PROPOSES

**FIRST.** – To approve the list of applicants who are provisionally granted the status of beneficiaries of the grant (ANNEX I) and the list of substitute applicants (ANNEX II), based on the total score obtained.

**SECOND.** – To grant a period of ten working days, starting from the day after the publication of this provisional proposal, for the beneficiary and substitute applicants to submit any objections via the email address [becas@fundacionyuste.org](mailto:becas@fundacionyuste.org), after which, if no objections are received, the proposed resolution will be considered definitive.

Once any objections submitted by the interested parties have been examined by the jury, if these concern the evaluation conducted, a report on the evaluation will be sent to the instructing body so that, in light of this, a final resolution proposal can be issued.

**THIRD.** – This provisional resolution proposal will be notified by sending a notice to the electronic device and/or email address provided by the interested party, informing them of the provisional list being made available on the Foundation's website < [www.fundacionyuste.org](http://www.fundacionyuste.org) > (Menu: "Carlos V European Award"/ Carlos V European Award Grants).

**FOURTH.** – This provisional resolution proposal does not grant any rights to the applicant until the definitive grant resolution is notified.

**FIFTH.** – This proposal, as an interim act, is not subject to appeal in accordance with Article 112.1 of Law 39/2015, of 1 October.
